### CALL FOR PAPERS

URSB is a government agency responsible for among others Insolvency matters. Annually, URSB publishes an Insolvency Journal in line with the strategic objective of promoting research, and deepening understanding of insolvency practices among the key stakeholders. The Journal aims to provide both authoritative and academic information on major topics and issues that are of importance to the development of insolvency law and practice in Uganda.

The Official Receiver is inviting submissions for publication in the third volume of the journal, which will cover a broad spectrum of insolvency issues, including but not limited to:

- a. Case reviews (for insolvency-related judgments).
- b. Creditor rights and participation in insolvency and restructuring proceedings.
- c. Regulation of Insolvency law and Practice.
- d. Cross-border insolvency in light of the new amendments in the Insolvency Act.
- e. Corporate rescue
- f. Pre-packs for SMEs.
- g. Bankruptcy, arrangements, administration and receiverships.
- h. International strategies of multinationals that have contributed to sound solvent entities.
- i. How Social, environmental, and political risk affect businesses.
- j. Company ownership and governance.
- k. Innovation and entrepreneurship in a BUBU context as a boost to a sound insolvency regime.
- l. Company solvency and performance persistence.
- m. Agricultural Finance, Policy, Credit, and Risk assessment as facilitators to corporate rescue.
- n. Company management, leadership, and sustainability for solvent entities.
- o. Company re-organisations, amalgamations, and restructuring.
- p. The UNCITRAL Model Law on Cross border insolvency.
- q. Sustainability of family businesses.
- r. Managing tax to avoid insolvency
- s. Dealing with intangible assets during insolvency proceedings

#### A few key points

- a) Any paper you submit to this journal should be original.
- b) By submitting your work to Uganda Registration Services Bureau, you are guaranteeing that the work is not in infringement of any existing copyright.
- c) Cite and fully reference all data, and methods in your paper.

## **Submission and approval of your Paper**

Soft copies of the Papers/ articles should be submitted to the Director of Insolvency and Receivership, Mugabe Robert at [robert.mugabe@ursb.go.ug](mailto:robert.mugabe@ursb.go.ug) by **30<sup>th</sup> August 2024**.

Acknowledgment of receipt of your article shall be within 24 hours of receipt.

All submitted Papers will be reviewed by members of the Editorial Board within four weeks from the date of submission. At this stage, they may choose to decline or accept your article depending on whether it fits the journal's aims and scope, or if they feel the language/manuscript quality is too low or generally substandard.

Written feedback will be given to the Author within a week after the initial review by the Editorial Board.

The Papers will be published upon acceptance and approval by the editorial board in both print and digital (URSB website).

A modest allowance of USD 200 (200 United States Dollars) will be extended to the writers of the approved and published papers. Authors of the published papers will also be accorded an opportunity to present their papers at the annual insolvency conference.

## **Correcting inaccuracies in your published paper.**

Sometimes errors are made during the research, writing, and publishing processes. When these issues arise, we have the option of withdrawing the paper or introducing a correction notice.

## **Author responsibilities.**

While we intend to offer you a professional and courteous experience at each stage of the review and publication process, we expect the following from the authors;

- a) Respond swiftly to any queries during the publication process.
- b) Treat communications between you and the journal editors as confidential until an editorial decision has been made.
- c) Acknowledge anyone who has made a substantial and meaningful contribution to the submission (anyone else involved in the paper should be listed in the acknowledgements).
- d) The author(s) is responsible for the work and accountable for its accuracy, integrity, and validity.
- e) Before submitting your work, it is your responsibility to check that the manuscript is complete, grammatically correct, and without spelling or typographical errors and that it conforms to the guidelines below;

Format	Paper files should be provided in Microsoft Word format. While you are welcome to submit a PDF of the document alongside the Word file, PDFs alone are not acceptable.
Paper length/word count	Papers should not be more than 6,000 words in length. This includes all text, for example, the structured abstract, references, all text in tables, and figures and appendices.
Paper title	A concisely worded title should be provided.
Author details	Please list the names of all contributing authors in the order in which you'd like them to be published. Ensure they include the <b>Author's email address</b> , <b>Author name</b> (We will reproduce it exactly, so any middle names and/or initials they want featured must be included), <b>Author affiliation</b> (This should be where they were based when the research for the paper was conducted.)
Biographies and acknowledgments	A brief professional biography and a daytime telephone contact as well as an email address of not more than 100 words should be supplied for each named author.
Structured abstract	All submissions must include a structured abstract, following the format outlined below. These four sub-headings and their accompanying explanations must always be included: <ul style="list-style-type: none"> <li>• Purpose</li> <li>• Design/methodology/approach</li> <li>• Findings</li> <li>• Originality</li> </ul> The maximum length of your abstract should be 250 words in total.
Article classification	During the submission process, kindly classify the paper as either ; <ol style="list-style-type: none"> <li>a) Research Paper</li> <li>b) Book Review</li> <li>c) Case Review</li> </ol>
Headings	Headings must be concise, with a clear indication of the required hierarchy. The preferred format is for first level headings to be in bold, and subsequent sub-headings to be in medium italics.
Notes/endnotes	Notes or endnotes should only be used if absolutely necessary. They should be identified in the text by consecutive numbers enclosed in square brackets.

References	<p>All references in your manuscript must be formatted using one of the recognised Harvard styles. You are welcome to use the Harvard style, we have provided a detailed guide below. Please ensure you check all your citations for completeness, accuracy and consistency.</p> <p><b>Emerald’s Harvard referencing style</b></p> <p>References to other publications in your text should be written as follows:</p> <ul style="list-style-type: none"> <li>• Single author: (Adams, 2006)</li> <li>• Two authors: (Adams and Brown, 2006)</li> <li>• Three or more authors: (Adams <i>et al.</i>, 2006) Please note, ‘<i>et al</i>’ should always be written in italics.</li> </ul> <p>A few other style points.
