IN EXERCISE of the powers conferred on the Minister responsible for justice by sections 263 and 294 of the Companies Act, 2012, these Regulations are made this 1st day of September, 2023.

1. Title

These Regulations may be cited as the Companies (Fees) (No. 2) Regulations, 2023.

2. Fees

The fees specified in the Schedule shall be paid in respect of the matters they relate to under the Companies Act, 2012 and the Regulations made under the Act.

3. Revocation of SI. No. 70 of 2023

The Companies Fees Regulations, 2023 are revoked.
