The data identification codes appearing in the next tables are WIPO Standards. The first three of these tables contain codes universally known as Internationally recognized Numbers for the Identification of Data (INID) codes.

These standards are namely, WIPO Standard ST. 60 (Recommendation concerning bibliographic data relating to marks) and Standard ST. 3 (Recommended standard on two-letter codes for the representation of states, other entities and intergovernmental organizations).

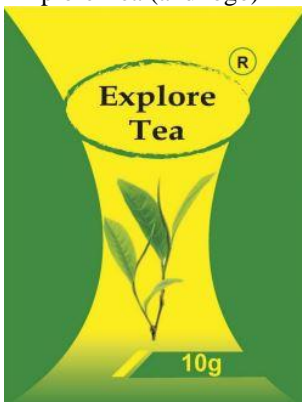
