NOTICE TO INSURANCE COMPANIES TO FILE ANNUAL RETURNS

Section 132 of the Companies Act, 2012 requires companies with a share capital to file annual returns to the Registrar of Companies. If, after expiry of five years any company has not filed any annual returns, the Registrar shall require the company to file a statement of solvency and show cause why the company should not be struck off the register.

Notice is hereby given to the insurance companies below to file a statement of solvency, and show cause why their companies should not be struck off the register within seven days from the date of this publication (July 25th 2019), or in the alternative adhere to the legal provisions by filing all outstanding annual returns.

If default is made in complying with this directive, the Registrar of companies shall proceed to strike any non-complaint company off the register forthwith.
